a. Anita Goldbaum\_introduced Mindy & Dora from the office of State Assemblyman Adrin Nazarian. Mindy, representative from the assemblyman's office, announced a certificate of recognition from the Assemblyman's office to NHWNC and Announced the Car Fit Event for Seniors.

#### 3. Presentations

a. Amelia Herrera-Robles – advise on the "how to's" in arranging a board retreat

Amelia Herrera-Robles from EmpowerLA provide a presentation on what would be required for a board retreat in addition to the invaluable information that can be derived from the meeting. She indicated that the retreat must be held within the NHWNC boundaries, it must be agendized and the public is welcome to attend as well.

#### 4. Officers reports

- a. President/Tino Julian/Absent Robin Tyler read a statement in absentia from Tino Julian stating why he is submitting his resignation as President from the NHWNC this issue will be brought up at the April 18<sup>th</sup> GBM for further discussion.
- b. Robin Tyler/Vice President Robin Tyler provided information regarding the proposed Water Tunnel project to be constructed in the Delta/Bay area. She announced that the North Hills West Neighborhood Council had been awarded The Best of Community Outreach to Take Back Neighborhood Council by VANC. Robin Tyler presented a certificate of appreciation to New Horizons for their support of the NHWNC, and to Dave Brown for providing audio support to NHWNC. Manager Abel Cervantes of Home Depot Van Nuys received a certificate of appreciation for generous donations to NHWNC Beautification & Infrastructure Clean Sweep Team, Yey and Roy Alcid for their service to providing the NHWNC's website.

- c. Debra Francisco/Secretary Debra Francisco advised the residents/stakeholders that committee applications were on the tab le and would welcome anyone to join.

She then read a letter written by members of NHWNC addressed to the mayor & city council and asked the audience members send it to the mayor. Garry Fordyce prepares to respond on the situation, and after Jaynee Thorne seconded the motion for the letter to be sent, Garry Fordyce gave a statement in stressing the importance of proper funding for the Neighborhood Councils. b. Motion to remove Marina Adlivankina from the Outreach committee

Glenn Bailey represented the North Ridge East Council Board also clarifying the situation. Mort Goldstein asked what impact there would be on the NHWNC to which Robin Tyler replied that there would be none. Peggy Burgess then clarified the boundaries of Woodley Hills then read a letter from the Woodley Hill residents to the NHWNC board thanking the board for their support for their name change. Marina Adlivankina gave the Beautification and infrastructure report, concerning the clean up event on Roscoe blvd and acknowledged Jaynee Thorne, Frank Klein, Mary Klein, David Brown, Darleen Rogers, and Punam Gohel for their assistance. Jaynee Thorne also commented on the benefits of the cleanup effort on the community.

b. Update and advise on planning April Clean Sweep

Jaynee Thorne presented the update and advised on planning April Clean Sweep. Someone in the audience asked if they have larger cones for the street while they're cleaning, and Jaynee Thorne answered that she is looking for some, but won't be there in time for the weekend.

c. Update and advise on creating a monthly standing clean up team

Marina Adlivankina advised that they have set up a monthly cleaning sweep starting with the March 24<sup>th</sup> cleaning; which will be held the last Sunday of every month.

### e. Motion to approve up to \$500 for senior dance May 31st

Nancy Xander stated her approval of the motion considering the popularity of the dance and the opportunity to nominate a senior volunteer for recognition. # f. Motion to approve up to \$1,000 donation for CD12 Family Fest

Robin Tyler motions to approve \$1000 Donation to Councilman Englander's Family Fest, and Anita Goldbaum Seconds. Robin Tyler explains the history of the festival. Mort Goldstein spoke concerning Englander's support of the NHWNC's initiative to deny Restaurant Depot building their headquarters in the neighborhood. Robin Tyler agreed stating she asked Councilman Englander's Office how the NHWNC can show support for him in turn. Vote: Approve 10, Oppose 0, Abstain 0; motion passed

### g. Update and advise on Greek Festival Memorial Day Weekend 25, 26, 27

Anita Goldbaum motioned the board to wait until David attends so he can speak about it. Debra Francisco seconds the motion. Vote: Approve 10, Oppose 0, Abstain 0; motion passed

# h. Discussion regarding "give aways" at sponsored events

Anita Goldbaum explained that the issue was discussed at the committee meeting but no dollar amount was delineated, and the audience was invited to share their ideas of what a good Item would be to give away at sponsored events. Jim Cockerel commented that while working in real estate, many people were most attracted to the flyswatter with the company logo. Marina Adlivankina suggested tote bags, Ernie Hilger suggested pins much like in the veteran's office. Darleen Rogers offered the use of a book of possible merchandise she received from a client who creates such items being discussed. And suggested going to local markets and supplying them with grocery bags with the NHWNC logo. Anita Goldbaum anyone else with ideas to email the idea to board@nhwnc.net Garry Fordyce suggested a solar powered led flashlight like the one Robin Tyler presented. He also stated that the NHWNC cannot solicit donations from local markets. Nancy Xander, suggested a Visor with a built in LED light.

### 11. Committee Reports/Planning and land use

### a. Motion to oppose the AGF ground box and cell tower

RobinTyler motions to oppose AGF ground box and cell tower to be installed. Peggy Burgess stated Neighborhood Councils cannot oppose specific AGF locations. And spoke on the AGF giving faulty information to residents concerning the installation process. John McGovern motions to send them a letter asking for proper notification from AGF with correct information. Anita Goldbaum asked if other Neighborhood council disapproved of the AGF installation methods, and suggested sending notice to the planning commission with many other neighborhood councils asking for better information. Robin Tyler stated there may be other issues affecting the situation. Glenn Bailey stated knowledge of a pending 3 point reform on in the city council dealing with cell towers that include changing cell tower location due to aesthetics and

moving boxes up to 500 feet instead of to the adjoining property. Robin Tyler then states that the NHWNC cannot oppose the AGF on this subject. Mike Majers says The city endorses the facility that Southern California Gas Co is preparing to install, so The NHWNC can oppose the installation, but cannot appeal the decision of the AGF. Anita Goldbaum makes the motion to oppose the instillation of the AGF cell tower and ground box to be installed at 16545 W. Vintage St. North Hills, CA. And the motion is withdrawn.

# b. Motion to oppose \$3billion street repair bill

Robin Tyler Reads a statement from LANC updating Neighborhood Councils on the issue as of Jan 10 2013. Glenn Bailey brings up the issue of due process on the measure, stating the measure wasn't given to the Neighborhood Councils to give them time to review the measure. And asked that in the motion that the 60 day notification period for Neighborhood Councils to review the tax be added. John McGovern seconds the motion to oppose the tax, Vote: Approved 9, Oppose 1, Abstain 0; motion passed

c. Motion to oppose homeowner proposal for zone change and subdivision for 10 homes

Robin Tyler Motion to postpone. John McGovern seconds Vote: Approve 10, Oppose 0, Abstain 0; motion postponed

d. Motion to approve homeowner request to enlarge a third house

John McGovern motion to approve homeowner request to enlarge third house case number ZA-2013-0235-ZAA-ZV. Robin Tyler\_explained the history of the motion and the support the Planning and land use committee has for this motion. Deborah Stevens seconds. Vote: Approve 9, Oppose 0, Abstain 1; motion passed
