- 3. New Business -public comment limited to 2 minutes per speaker.
  - A. Discussion & possible motion to select a vendor for quality recyclable grocery bags, printed with the NHWNC logo and information on one side. Funding of up to \$800 already approved by the Board on August 21, 2014. Vendor quotes to be presented at Board meeting for Board consideration.
