<u>Discussion and possible Motion: Shall NHWNC join the City's Neighborhood Council Sustainability Alliance?</u> The Neighborhood Council Sustainability

Alliance (NCSA), founded in 2014, advances sustainability and resilience across Los Angeles through advocacy, sharing of best practices, and community action.

The NCSA holds regular public forums and events, and collaborates with Neighborhood Councils, City agencies, and environmental and other community

organizations to support effective engagement on L.A.'s new Sustainable City Plan, drought response strategies, the region's Climate Action Framework,

and other timely sustainability initiatives. The NCSA governing Board is comprised of Stakeholders from NCs across the City, and holds monthly meetings

at TreePeople, an environmental non-profit. They invite all Neighborhood Councils to join the alliance. The board has reviewed the bylaws of the council and,

if membership is approved, agrees to the following resolution:

<u>Upon recommendation from the Emergency Preparedness Committee - Motion and Possible action concerning filing a Community Impact Statement to support CF 14-1697.</u> Establishes enhanced mandatory minimum standards for both existing wood frame and non-ductile concrete buildings applicable to all buildings constructed prior to January 13, 1977. Wood frame construction: Except: 3 dwelling units or less, residential only use. Concrete construction: Except detached single family dwellings or detached duplexes in both types of construction if tenant ability is affected for more than 30 days. The affected tenant has the option

to voluntarily terminate the tenancy in exchange for permanent relocation assistance. Plus applicable return of security deposit.
