**General Board Meeting Minutes** Thursday, Dec. 15, 2016 New Horizons, 15725 Parthenia St., North Hills CA 91343

# 1. Welcome and Pledge of Allegiance.

President Dan Gibson called the Meeting to order at 7:03 p.m. The Pledge of Allegiance was said.

# 2. Roll Call and announcement of Quorum and Voting Eligibility.

Roll Call was taken by the Secretary. Twelve of the 13 Board Members were present at the Roll Call: Dan Gibson (President), David Phelps (Vice-President), Dave Brown (Secretary), Jay Beeber, Armando Diaz (Treasurer), Garry Fordyce, Punam Gohel, Carol Hart, David Hyman, Sam Kwasman, Madlena Minasian and Kreshell Ramey. Antonino Lovato arrived later. The NHWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is seven (see https://lacity.quickbase.com/db/bj3apxsp3? a=q&qid=32&qskip=0&qrppg=1000&dlta=su46~), so the Board could take such votes. Quorum was announced. Mr. Brown reported that all Board Members were eligible to vote. All 13 Board Seats were filled (by election or appointment). No Board Seats were vacant. Also attended: 27 Stakeholders and quests.

Ruby Chavez, Chief of Staff for LAUSD Board Member Monica Ratliff (ofc. 818-252.5445; Ruby.Chavez@lausd.net; http://Ratliff.LASchoolBoard.org), reported that the elementary school semester ends Dec. 16<sup>th</sup>; winter classes are available for high school students. Classes resume January 9<sup>th</sup>. Martin Luther King Day will be honored on Monday, January 16<sup>th</sup>.

Dr. Steve Fleischer encouraged attending the City Hearing regarding the 18-Bed Congregate Living Health Facility proposed for 16052 W. Chase St. Ben Fiss (land use consultant representing that proposal; 818-522-2823; Ben@PacificZoning.com) reported that he requested the City to "continue" the Hearing "at least until February . . . to see if there are any grounds to modify the project."
