 - A. Discussion and possible motion to approve a B&I committee recommendation that the NHWNC Board urgently review and approve a Funding Request to pay for additional pavement repair in the most damaged of our alleys.
 - 1. **Problem**: Pavement of many NHWNC alleys has degraded since first built but there is no city program or budgeted funding for alley repairing or pothole repairs.
 - 2. Proposed Solution: NHWNC may approve the expenditure of [up to] \$3000 of the total of \$8000 originally allocated to the Beautification and INFRASTRUCTURE Committee for the purpose of paying for targeted repairs via engagement of the BSS for up to 3 Small Asphalt Repair Trucks (2 3 ton, and 1 5 ton) and their crews at a rate of \$2400 (\$1200x2x1day) + \$600x1x1day = \$3000. (verbal estimate provided by Larry Hreza, BSS Field Supervisor)
 - 3. **Motion**: As the FYE falls on June 30th, and the deadline for all Funding submissions is June 1st, at 11:59pm, shall the B&I committee recommend that the NHWNC Board *immediately approve* the attached Funding Request to pay the sum of \$3000 to the Department of Public Works Bureau of Street Services (City of Los Angeles) for Small Asphalt Repair of heavily worn alleys throughout the NHWNC district? (This is pursuant to specification BSS-NCI assessment.)

- B. Discussion and possible approval of a community outreach campaign (low or no cost, mostly electronic) to request stakeholder input about the about the top 5 10 sites most in need of clean-up and pothole repair.
 - 1. Stakeholders are invited to submit recommendations to board@nhwnc.net. The B&I Committee will discuss and prioritize highest impact sites (based on quality of life and traffic considerations) for future discussion and project scheduling upon board approval.
 - 2. Discussion to initiate planning of *separate* Volunteer-based clean-up and landscaping projects.
 - a) Water line repair and planting of NHWNC Planters located on the SW corner of Hayvenhurst & Plummer (Recommend drought-tolerant, California Natives to support native birds & bees.)
