Summary of Motions Introduced (*New Legislation*)

Council File 24-0055, Gas-Powered Leaf Blowers / Fiscal Year 2022-23 Complaints and Citations / Enforcement / Education Program (Raman – Blumenfield):

Introduced January 16, 2024 and referred to Public Works Committee. Motion is instructing the Bureau of Street Services (BSS) to report within 60 days on the number of complaints received and the number of citations issued for gas-powered leaf blower violations in Fiscal Year 2022-23. Data should include the BSS enforcement area and the Council District in which the citation was issued.
