



NORTH HILLS WEST NEIGHBORHOOD COUNCIL Regular Board Meeting Minutes, Thursday, March 16, 2023 Minutes Approved 4/16/2023

In conformity with the Governor's Executive Order N-29-20 (March 17, 2020) and due to concerns over COVID-19, this duly noticed meeting was held entirely online and telephonically.

1. Welcome, Call to Order and Flag Salute.

President Madlena Minasian called the Meeting to order at 6:01 p.m. The Pledge of Allegiance was said.

2. Roll Call, Determination of Quorum, Voting Eligibility Report and call for agenda item(s) recusals.

Roll Call was taken by the Minutes Writer. Nine of the 10 Board Members were present online at the Roll Call: Dave Brown (Secretary), Pat Crone (Treasurer), Maggie Elliott (Vice-President), Linda Erdman, Garry Fordyce, Punam Gohel, David Hyman, Madlena Minasian (President) and Kreshell Ramey. Carol Hart arrived later. No Board Members were absent. The NHWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is seven (see the Bylaws link at www.empowerla.orgnhwnc), so the Board could take such votes. Quorum was announced. Mr. Brown confirmed that all Board Members' trainings were compliant and they were eligible to vote. Ten of the 13 Board Seats were filled (by election or appointment). Three Board Seats were vacant (two General and one Residential); to apply, email Secretary@nhwnc.net. Also attended: at least 16 Stakeholders and guests.

 Thomas Soong, Director of Outreach and Communications for the L.A. Dept. of Neighborhood Empowerment (DONE) [213-978-1551], reported that the new DONE Interim General Manager is Vanessa Serrano. He said "I understand that the last couple of months you haven't had representation from our Department"; he acknowledged that Mr. Darnell was not present but "should be back on the 20th; if not I'll let the Board know." He noted that "a portion of the [DONE] website is down." As of March 30th all NC meetings will be in person, though "teleconferencing" also is allowed with conditions.

 Mr. Fordyce, a Budget Advocate [LABudgetAdvocates@gmail.com], reported that meetings continue with City department heads. Budget Day will be June 17th. Ms. Minasian asked how much funding the Advocates have and how it is used. Mr. Fordyce replied that they have \$49,000 in funds "used for Budget Day . . . expenses in City Hall . . . security . . . rooms on the 10th floor . . . regional breakout days . . . [food] . . . media-type things that go out . . . I'm not sure what they're spending that on specifically anymore . . . "

- 5. <u>General Public Comment</u>: Each speaker can speak one time for up to one (1) minute. PLEASE ADVISE IF YOU ARE A PAID LOBBYIST, THANK YOU. Comments from the public on non-agenda items within the Board's jurisdiction. Our scope is limited to City and, occasionally, County Issues.
 - Caller/user #1 said to Mr. Soong, "Your LA Empower website roster is down"; he noted possible "hacking of all the Neighborhood Council Board Members' personal information, including their applications . . ." Mr. Soong acknowledged that "the

website is down . . . I'll definitely put that communication [regarding hacking] out to your Board and other Boards regarding that issue . . ." Guest Glenn Bailey announced that the next Congress of Neighborhood Councils will be in-person on September 23rd; the preliminary budget for it is \$72,000 and funding is being solicited from NCs. Resident Debra Francisco thanked Ms. Minasian for "doing a wonderful job as President" and "wanted to commend [her] for [her] service" as President, and also the other Board Members; "you guys are great, giving up your time -- without pay, by the way. In the future, I hope we will not have others from NCs pushing their Agenda and what they want to see our President and you Board Members do. We want our Board to be North Hills West . . . you guys are doing great. I want to thank you very, very much. I really appreciate it."

Resident Steve Thomason said "I want to thank all you guys on this Board." He heard another NC's Board Member "badmouthing this Board" at a Granada Hills North or South Board Meeting about something that happened at the NHWNC "15 or 20 years ago." Mr. Thomason said that that other NC's Board Member "constantly interrupt[s] and waste[s] our time" with things "that have nothing to do with us." Guest Brian Allen announced that "whenever you see my name on your meeting, you will know that I am recording your meeting and I really don't appreciate you coming out, you having your people come out and criticize other people when it is improper to do that. You should be much more considerate of Stakeholders. Everyone in this city is a Stakeholder of every part of the City, so don't misunderstand what [unintelligible] . . ."

 Ms. Erdman announced that the next Van Nuys Airport Neighborhood Coalition meeting will be April 4th; around 60 people attended the first meeting. Also, she submitted more Community Impact Statements.

Board Member Carol Hart had arrived by this time, making all 10 Board Members present (the NHWNC quorum is seven).

FUNDING MOTION PASSED by a roll call vote of the 10 eligible voters present with eight in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart, Hyman and Minasian); one opposed ("No" or "Nay") (Fordyce); one abstained (the NHWNC does not count abstentions as votes) (Ramey).

The next Item addressed was Item #4. c.

10. <u>Discussion and possible action</u> to add a Standing Rule (SR) that committee chairs may agendize a joint meeting for certain purposes, such as allowing greater participation by Board members at committee meetings. Any agenda for a joint Board/committee meeting must make clear that the meeting is solely noticed as a joint Board and committee meeting to accommodate Board participation and compliance with the Brown Act, that any items considered at the joint meeting will only be voted upon by the committee members (not other Board members in attendance), and that the matters voted upon will be referred to the full Board for discussion and possible action at a future agendized date and time.

MOTION (by Ms. Minasian, seconded by Ms. Elliott): The North Hills West Neighborhood Council adds a Standing Rule (SR) that committee chairs may agendize a joint meeting for certain purposes, such as allowing greater participation by Board members at committee meetings. Any agenda for a joint Board/committee meeting must make clear that the meeting is solely noticed as a joint Board and committee meeting to accommodate Board participation and compliance with the Brown Act, that any items considered at the joint meeting will only be voted upon by the committee members (not other Board members in attendance), and that the matters voted upon will be referred to the full Board for discussion and possible action at a future agendized date and time.

DISCUSSION: Mr. Fordyce stated that "Joint meetings are not part of the Brown Act and it also has been stated numerous times at other venues this year that joint meetings are very limited in their use and they're not supposed to be a routine . . . this is not going to be . . . in compliance with the Brown Act or instruction that we've been receiving from the Department." Mr. Brown confirmed that "the wording is copied directly from the EmpowerLA guidance . . . this is not meant to be a routine occurrence . . . " Mr. Soong explained that the purpose of joint meetings is to "to let the public know . . . that a majority of the Board . . . will be there in attendance . . . it is to be used on rare occasions; as long as you follow the guidance that has been provided here, you should be okay."

Board Member Punam Gohel was unavailable to vote at this time, making nine Board Members present online (the NHWNC Board quorum was seven).

MOTION PASSED by a roll call vote of the nine eligible voters present with eight in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Hart, Hyman, Minasian and Ramey); one opposed ("No" or "Nay") (Fordyce); zero abstained.

The next Agenda Item addressed was Item #4. b.

11. <u>Discussion and possible action</u> regarding Senate Bill SB411 Neighborhood Council Virtual Meetings. https://legiscan.com/CA/text/SB411/2023. MOTION: The NHWNC approves a resolution in support of SB411 allowing Neighborhood Councils to indefinitely hold virtual/hybrid Board and/or Committee meetings.

MOTION (by Ms. Hart, seconded by Ms. Elliott): The North Hills West Neighborhood Council approves a resolution in support of SB411 allowing Neighborhood Councils to indefinitely hold virtual/hybrid Board and/or Committee meetings.

DISCUSSION: Mr. Fordyce "there's a number of issues here . . . now you've got a train wreck with Assembly Bill 2449 . . . I don't think the Neighborhood Council is going to be allowed to rewrite this section. So, nobody has really taken a close look at this. If I'm correct . . . the way you're voting on this it's a train wreck." Mr. Brown clarified that "we're not rewriting anything; we're just saying we wish to have the option . . ." Mr. Soong recommended removing the word "/hybrid." Ms. Erdman encouraged sending the letter to the State Senator. Mr. Fordyce claimed that "Board Members are still speaking out that we're going to send this to our State Senator." Ms. Minasian suggested deleting the word "hybrid" from the Motion; Mr. Soong agreed.

AMENDED MOTION (by Mr. Fordyce, seconded by Ms. Hart): delete the word "/ hybrid" and, on the end, add the words "and further requests to include elected and selected Neighborhood Council Board Members," so that the Motion is "The North Hills West Neighborhood Council approves a resolution in support of SB411 allowing Neighborhood Councils to indefinitely hold virtual Board and/or Committee meetings and further requests to include elected and selected Neighborhood Council Board Members."

AMENDED MOTION PASSED unanimously by a roll call vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Hart, Hyman, Minasian and Ramey); zero opposed; zero abstained.

12. <u>Discussion and possible action</u> regarding CF 23-0002-S16. Neighborhood Council Board members are all unpaid volunteers who oxen have obligations beyond their extensive volunteer duties. We have child and elder care obligations, work obligations, health concerns, and many other obligations in our daily lives. Access via telephonic meetings have allowed a wider variety of stakeholders to participate in meetings and serve on Boards. Neighborhood Councils desperately

need options that allow them choices for virtual/hybrid meetings that best suit the needs of their individual community. MOTION: The NHWNC supports urgent changes to the Brown Act which would allow Neighborhood Councils the option to continue to hold virtual/hybrid Board and/or committee meetings.

Mr. Brown explained the Motion.

MOTION (by Mr. Brown, seconded by Mr. Hyman): The North Hills West Neighborhood Council supports urgent changes to the Brown Act which would allow Neighborhood Councils the option to continue to hold virtual/hybrid Board and/or committee meetings.

DISCUSSION: Mr. Brown said "we're just asking for the option." Ms. Hart said "we're just expressing our wishes." Mr. Soong recommended using the word "remote."

AMENDED MOTION (by Mr. Brown, seconded by Ms. Hart): replace the wording "continue to hold virtual/hybrid Board and/or committee meetings" with "to choose to operate remote meetings indefinitely," so that the Motion is "The North Hills West Neighborhood Council supports urgent changes to the Brown Act which would allow Neighborhood Councils the option to choose to operate remote meetings indefinitely."

AMENDED MOTION PASSED unanimously by a roll call vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Hart, Hyman, Minasian and Ramey); zero opposed; zero abstained.

13. <u>Discussion and possible action</u> regarding CF 22-1019 (Rodriguez – Lee – et al.) MOTION: The NHWNC supports CF 22-1019 relative to takeovers involving street intersections, street segments or other public rights-of-way; and to identify locations with the highest volume of calls regarding this issue citywide; and related matters. https://cityclerk.lacity.orglacityclerkconnect/index.cfm? fa=ccfi.viewrecord&cfnumber=22-1019

Mr. Brown explained the Motion, noting that some takeovers include gunfights.

MOTION (by Mr. Brown, seconded by Mr. Fordyce): The North Hills West Neighborhood Council supports Council File 22-1019 relative to takeovers involving street intersections, street segments or other public rights-of-way; and to identify locations with the highest volume of calls regarding this issue citywide; and related matters.

MOTION PASSED by a roll call vote of the nine eligible voters present with eight in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Hart, Hyman and Minasian); zero opposed; one abstained (the NHWNC does not count abstentions as votes) (Ramey).

14. <u>Discussion and possible action</u> regarding CF 23-0214, weather-related emergency communications. MOTION: The NHWNC supports CF 23-0214 regarding weather-related emergency communications. https://cityclerk.lacity.orglacityclerkconnect/index.cfm? fa=ccfi.viewrecord&cfnumber=23-0214

Ms. Erdman explained the Motion.

MOTION (by Ms. Erdman, seconded by Ms. Hart): The North Hills West Neighborhood Council supports Council File 23-0214 regarding weather-related emergency communications.

DISCUSSION: Mr. Brown urged everyone to have a battery-powered radio.

Board Member Punam Gohel had returned by this time, making all 10 Board Members present (the NHWNC quorum is seven).

MOTION PASSED unanimously by a roll call vote of the 10 eligible voters present with all 10 in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Hyman, Minasian and Ramey); zero opposed; zero abstained.

15. <u>Discussion and possible action</u> regarding CF 23-0002-S29. Senate Bill SB 55 prohibits sales of motor vehicle with un-etched catalytic converters. MOTION: The NHWNC supports CF 23-0002-S29 prohibiting sales of motor vehicle with un-etched catalytic converters. hips://cityclerk.lacity.orglacityclerkconnect/index.cfm? fa=ccfi.viewrecord&cfnumber=23-0002-S29

Ms. Erdman explained the Motion.

MOTION (by Ms. Erdman, seconded by Mr. Hyman): The North Hills West Neighborhood Council supports Council File 23-0002-S29 prohibiting sales of motor vehicles with un-etched catalytic converters.

DISCUSSION: Ms. Elliott noted that her catalytic converter was etched.

MOTION PASSED unanimously by a roll call vote of the 10 eligible voters present with all 10 in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Hyman, Minasian and Ramey); zero opposed; zero abstained.

Board Member David Hyman stepped out of the meeting by this time, making nine Board Members present online (the NHWNC quorum is seven).

16. <u>Discussion and possible action</u> to approve New Horizons as the primary ongoing in-person meeting venue. MOTION: The NHWNC approves New Horizons as the primary ongoing in-person meeting venue at a quoted rate of a \$400 per month, which includes technical support infrastructure for hybrid (Zoom) participation, and the Mid-Valley Regional Library as a backup location. Both locations have met the required pre-approval ADA accessibility criteria.

FUNDING MOTION (by Ms. Minasian, seconded by Ms. Elliott): The North Hills West Neighborhood Council approves New Horizons as the primary ongoing inperson meeting venue at a quoted rate of a \$400 per month, which includes technical support infrastructure for hybrid (Zoom) participation, and the Mid-Valley Regional Library as a backup location. Both locations have met the required preapproval ADA accessibility criteria.

DISCUSSION: Ms. Minasian clarified that only New Horizons would be paid; the Library would be free. Mr. Brown noted that many such locations charge \$500-\$1,500 per month. Ms. Francisco said "New Horizons is wonderful . . . \$400 per month is reasonable." It was noted that the NHWNC met at New Horizons for many years, at only \$180 per month, before the pandemic. Mr. Soong offered to help get the Library as a backup.

FUNDING MOTION PASSED unanimously by a roll call vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Minasian and Ramey); zero opposed; zero abstained.

17. <u>Discussion and possible action</u> to support continuing the City's Neighborhood Prosecutor Program. Recent news suggests the very successfully Neighborhood Prosecutor Program may change. Currently a dedicated imbedded Prosecutor within each Division has been a game changer for the better. A geographically knowledgeable prosecutor has a significant advantage over downtown randomly assigned staff. MOTION: The NHWNC will submit a letter to the City Attorney's Office requesting to retain an embedded Neighborhood Prosecutor in each LAPD Division.

Mr. Brown showed onscreen and read aloud a draft letter. Ms. Minasian noted that the draft letter is and has been posted on the NHWNC website.

MOTION (by Mr. Brown, seconded by Ms. Crone): The North Hills West Neighborhood Council will submit a letter to the City Attorney's Office requesting to retain an embedded Neighborhood Prosecutor in each LAPD Division.

MOTION PASSED unanimously by a roll call vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Minasian and Ramey); zero opposed; zero abstained.

18. <u>Discussion and possible action</u> to approve an amount not to exceed \$2,000 outreach. MOTION: The NHWNC approves an amount not to exceed \$2,000 for multiple types and phases of outreach modes, including flyers for NHWNC promotion and final election outreach.

Ms. Hart explained the Motion and noted that only one printer so far has quoted under a \$2.000 cost.

FUNDING MOTION (by Ms. Hart, seconded by Ms. Crone): The North Hills West Neighborhood Council approves an amount not to exceed \$2,000 for multiple types and phases of outreach modes, including flyers for NHWNC promotion and final election outreach.

DISCUSSION: Mr. Fordyce stated that the funding would be for "multiple undefined types and undefined modes and phases of outreach . . . I would think you would focus on the election . . . Now you want to focus on everything under the sun . . . this is so vague and it's a blank check." Ms. Hart said that "our outreach serves multiple purposes . . . outreach is vitally important, since we haven't been able to go out into the community and talk to our Stakeholders for three whole years . . . to encourage people to . . . get involved." Ms. Minasian noted that DONE has not helped with election outreach. Mr. Soong acknowledged Ms. Minasian's concern and said that DONE "will supplement" the NHWNC's outreach funding. He explained that, if there are not enough candidates, there would be "a Board affirmation . . . [per the] loss of quorum policy that would allow . . . your new Board to lower the quorum so that the Board could meet and appoint Board Members up to the quorum number . . . " Ms. Hart noted that she's "not the only one who does not plan to run again . . . I need to focus on my health. I'm going to be leaving." There was more extensive discussion regarding NHWNC outreach and volunteer needs.

FUNDING MOTION PASSED by a roll call vote of the nine eligible voters present with five in favor ("Yes" or "Aye") (Brown, Crone, Gohel, Hart and Minasian); three opposed ("No" or "Nay") (Erdman, Fordyce and Ramey); one abstained (the NHWNC does not count abstentions as votes) (Elliott).

19. <u>Discussion and possible action</u> on NHWNC/Committee/Liaison/CIS filers appointments to add/remove.

Mr. Brown, Ms. Minasian and Ms. Hart thanked Ms. Erdman for filing Community Impact Statements [CISs]. Mr. Soong reported that DONE has "been working on a new portal." There were no appointments or changes at this time.
