



# NORTH HILLS WEST NEIGHBORHOOD COUNCIL Regular Board Meeting Minutes, Thursday, April 20, 2023 New Horizons, 15725 Parthenia St., North Hills, CA 91343

### 1. Welcome, Call to Order and Flag Salute.

President Madlena Minasian called the Meeting to order at 6:06 p.m. The Pledge of Allegiance was said.

# 2. Roll Call, Determination of Quorum, Voting Eligibility Report and call for agenda item(s) recusals.

Roll Call was taken by the Secretary. Seven of the 10 Board Members were present at the Roll Call: Dave Brown (Secretary), Pat Crone (Treasurer), Maggie Elliott (Vice-President), Linda Erdman, Garry Fordyce, Carol Hart and Madlena Minasian (President). Punam Gohel and Kreshell Ramey arrived later. David Hyman was absent. The NHWNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is seven (see the Bylaws link at <a href="https://www.empowerla.org/nhwnc">www.empowerla.org/nhwnc</a>), so the Board could take such votes. Quorum was announced. Mr. Brown confirmed that all Board Members' trainings were compliant and they were eligible to vote. Ten of the 13 Board Seats were filled (by election or appointment). Three Board Seats were vacant (two General and one Residential); to apply, email Secretary@nhwnc.net. Also attended: 21 Stakeholders and guests.

  Mr. Fordyce, a Budget Advocate [LABudgetAdvocates@gmail.com], reported that the City budget greatly increased. He commented that "where this money is coming from, nobody knows . . . [the Mayor] is turning down Departments . . . we're all going to suffer . . . this is my view."

#### 5. General Public Comment

Guest Glenn Bailey, "speaking as an individual," said the Mayor proposed that Neighborhood Councils still get \$32,000 per year in funding and be allowed to roll over \$10,000 in funding from the previous Fiscal Year [ending June 30<sup>th</sup>]. Guest Samantha Trainer and her son asked for funding for the Vintage Magnet Elementary School [https://www.vintagemagnet.net] grades three through five Robotics Team. The Team has 120 members; 14 are going to the World Championships. Ms. Minasian explained the need to complete a Neighborhood Purposes Grant application. Resident Debra Francisco welcomed everyone and thanked the Board for their service, as did guest Steve Thomason. Ms. Minasian read aloud an

anonymous email that requested meetings "be focused on community needs," avoiding "unnecessary complaints."

Board Members Punam Gohel and Kreshell Ramey arrived at this time (6:51), making nine Board Members present (the NHWNC quorum is seven). The next Agenda Item addressed was Item #7.

#### 6. <u>Guest Speakers and Informational Presentations.</u>

A. City Of Los Angeles Urban Forestry Division: Stephen Du Prey, Nikki Ezhari, Elias Najar. Presentation regarding available programs and options to get more trees planted faster. North Hills West Neighborhood Council District Street Tree Summary NHW has 3,583 trees (58%), 253 stumps and 2,473 vacant sites (43%)

The presentation was made and questions answered. It was reported that the City plans to trim 1,500 North Hills trees this year. Mr. Najar said "research shows that planting a tree on your property can increase the property value five percent." Mr. Fordyce questioned that data, saying "are we not to understand the facts?" Mr. Du Prey described benefits of having a tree, including shade and lower cooling costs. He said "we're a mulch facility, not a compost facility . . . the quality of the mulch is superb" and the City "can drop it off . . . [for] free." He noted that "a tree should be trimmed every three to five years." Currently the City is trimming "every 17 years . . . you're all welcome" to tour their facility. The goal is to replace every tree removed; more City funding is needed. Urban Forestry has "4,000 requests for emergency services"; you can use a licensed contractor to trim trees.

B. City of Los Angeles L.A. REPAIR Grant Participatory Budgeting: Elliot Kuhn. Voting is open this month and the proposal with the most votes will receive funding. Select your REPAIR Zone to learn how to vote and read the proposals on the ballot: https://www.nhwnc.net/l-a-repair-participatory-budgeting/

Mr. Kuhn explained that their Panorama City facility at 8380 Ventura Canyon Avenue is open every Saturday 9:00 a.m. - noon. Shade trees are available "free to the public." Free mulch is available and they "also run a community composting hub." They're working to create community gardens. They also work with high school students, who learn food growing and gardening skills, and the LAPD PALS and other organizations.

**MOTION** (by Ms. Minasian, seconded by Ms. Erdman): The North Hills West Neighborhood Council approves the Minutes of its March 16, 2023 Regular Board Meeting.

**DISCUSSION**: Mr. Fordyce claimed that the March 16<sup>th</sup> Item #10 Minutes showed no Motion mover or seconder; it was noted that the Minutes did and do show a mover and a seconder.

**MOTION PASSED** by a roll call vote of the nine eligible voters present with eight in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart and Minasian); zero opposed; one abstained (the NHWNC does not count abstentions as votes) (Ramey).

**FUNDING MOTION** (by Ms. Erdman, seconded by Ms. Hart): The North Hills West Neighborhood Council approves the Monthly Expenditure Report for March 2023.

**FUNDING MOTION PASSED** by a roll call vote of the nine eligible voters present with seven in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart and Minasian); two opposed ("No" or "Nay") (Fordyce and Ramey); zero abstained.

The next Agenda Item addressed was Item #6. A.

**9.** <u>Discussion and possible action</u> to approve a Neighborhood Purposes Grant (NPG) for \$1,729.50 for Mid-Valley Regional Library for a video projector.

Ms. Magaw presented on behalf of the Friends of the Library. She said the projector "will be available for the NHWNC when they need it" and confirmed that the NHWNC can take it off-site. The \$1,729.50 is "the total amount that we were quoted by the vendor." Mr. Fordyce stated that addressing this Item is "a violation of the Brown Act. We were told we couldn't ask questions at meetings" and this Item "was not Agendized." In reply to Ms. Minasian noting that it was Agendized, Mr. Fordyce said "that is not relevant." She confirmed that this Item was Agendized for the [April 17th] Budget & Finance Committee meeting; he still claimed otherwise. He insisted that the application needed to list Friends of the Library Members; it was confirmed that there was no need to list Friends of the Library Members on the application. Then Mr. Fordyce challenged and wanted to discuss Ms. Hart's eligibility to be a Board Member. Ms. Hart again explained her multiple qualifications and noted that discussion of her eligibility is not Agendized. Mr. Darnell confirmed that "if it's not on the Agenda, it can't be discussed." Ms. Minasian requested of Mr. Darnell and he agreed that he will report back to her whether it was a Brown Act violation for Mr. Fordyce to discuss at this time the unagendized topic of Ms. Hart's Board member qualifications. Mr. Brown noted that, at the Budget & Finance Committee meeting, "there were copies" available of all information, including the Agenda, and that it was "his [Mr. Fordyce's] option not to" look at it. Ms. Francisco noted that "the Library is in our District . . . that money goes for all of us . . . it has nothing to do with conflict of interest . . . interferencing from other people to our Council should not be made." Mr. Fordyce wanted the NPG application to show that the item number eight answer is "no" and item number 11 is blank.

**FUNDING MOTION** (by the Budget and Finance Committee): The North Hills West Neighborhood Council approves a Neighborhood Purposes Grant (NPG) for \$1,729.50 for Mid-Valley Regional Library for a video projector . . . with corrections on the NPG that the line eight answer is "no" and that line 11. B. will be blank.

**FUNDING MOTION PASSED** by a roll call vote of the nine eligible voters present with seven in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart and Minasian); two opposed ("No" or "Nay") (Fordyce and Ramey); zero abstained.

**10.** <u>Update regarding the status Volunteers Cleaning Communities NPG</u> for \$1500 for Tools and Supplies. Agendized and approved on April 21, 2022 General Board Meeting.

Ms. Minasian asked Ms. Hart about the location and status of the tools and supplies. Ms. Hart stated that she "was told they were purchased; I don't know where they're stored." Ms. Hart said that she explained to Jill Mather [Founder of "Volunteers Cleaning Communities," VCC; JillMather@earthlink.net], the need "for a follow-up report," but Ms. Mather hasn't answered. Ms. Elliott reported the same. Mr. Brown reported that nothing has yet been purchased. There was discussion about funding allocated by the City but the NHWNC not getting any information from VCC. Ms. Ramey said she "will talk with" Ms. Mather and notify the Board. Mr. Fordyce said he "never heard about any" cleanups; other Board Members noted that multiple cleanups have been posted on the NHWNC website. Mr. Fordyce questioned why funding was allocated since the City can provide free equipment. Ms. Minasian explained to him that "this is an update." No Motion was made or vote taken.

#### 11. Board Member announcements and comments.

Mr. Fordyce requested to adjourn in memory of former L.A. Mayor Richard Riordan, who passed away the day before. Mr. Brown recommended attending an active shooter presentation. Ms. Erdman commented on the Van Nuys Airport Citizens Advisory Committee meeting she attended; the next will be May 2<sup>nd</sup>. Ms. Hart commented that CD12 can help getting free trees.

**12.** <u>Discussion and possible action</u> on NHWNC/Committee/Liaison/CIS filers appointments to add/remove.

A verbal update was given by the City Clerk Funding Unit regarding citywide NC funding; the \$4 million annual NCs budget was reported by categories. BONC will update the NCs Code of Conduct. A joint presentation was made by the City Clerk Election Division and DONE regarding 2023 NC elections. They've received 1,585 NC Board Candidate applications; 1,305 were so far certified. One-third of NCs will have affirmations, not elections. The BONC meeting ended because they lost quorum.
