Motion is requesting the City Attorney to draft a municipal ordinance incorporating the entirety of Los Angeles County Code, sections 11.01.010 through 11.0.090, Ordinance titled the “Preventing Retaliation for Reporting Public Health Violations Ordinance,” as amended by Los Angeles County Ordinance 2023-0035 to protect City of Los Angeles workers from retaliation for reporting public health concerns.
