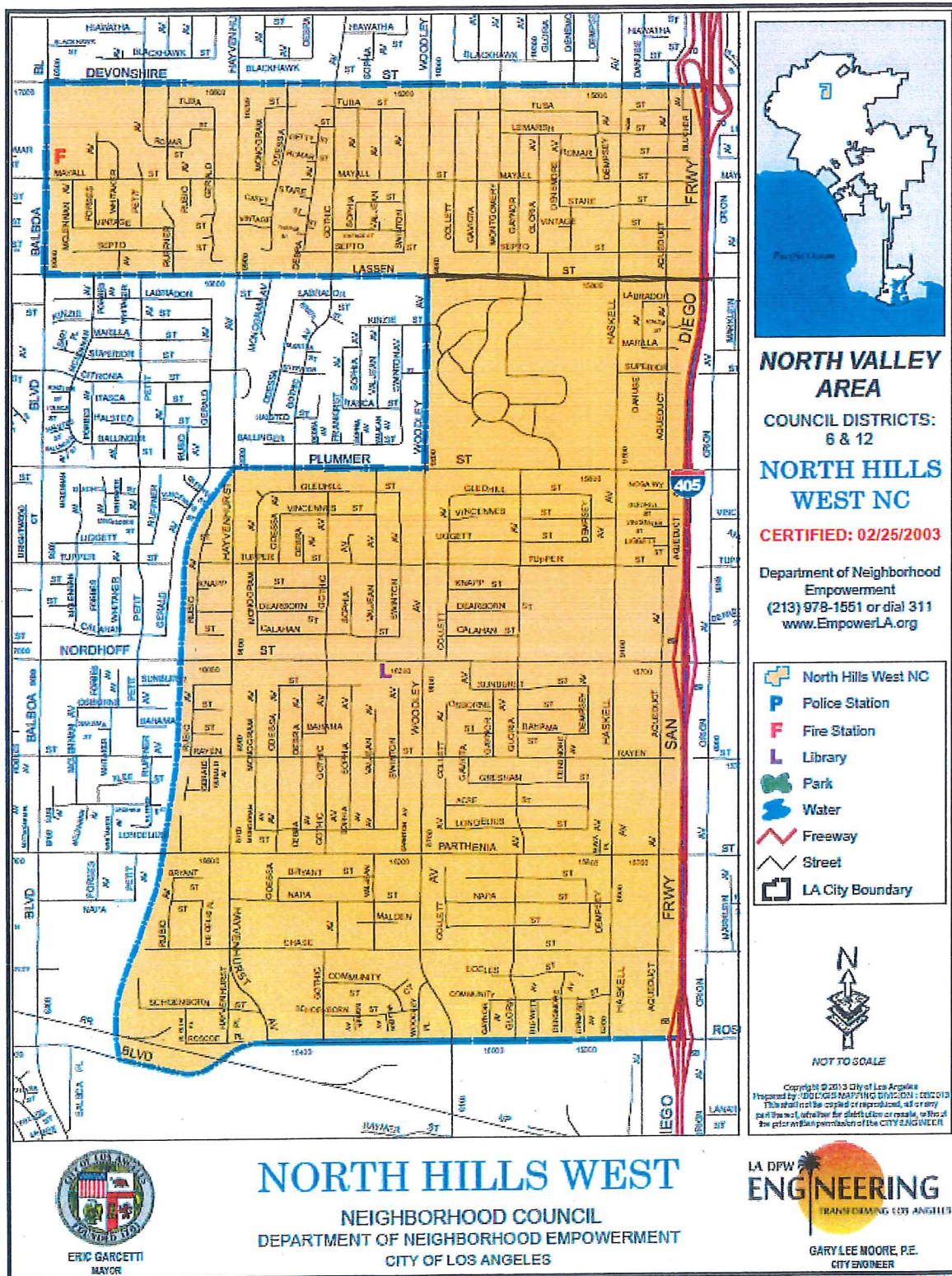

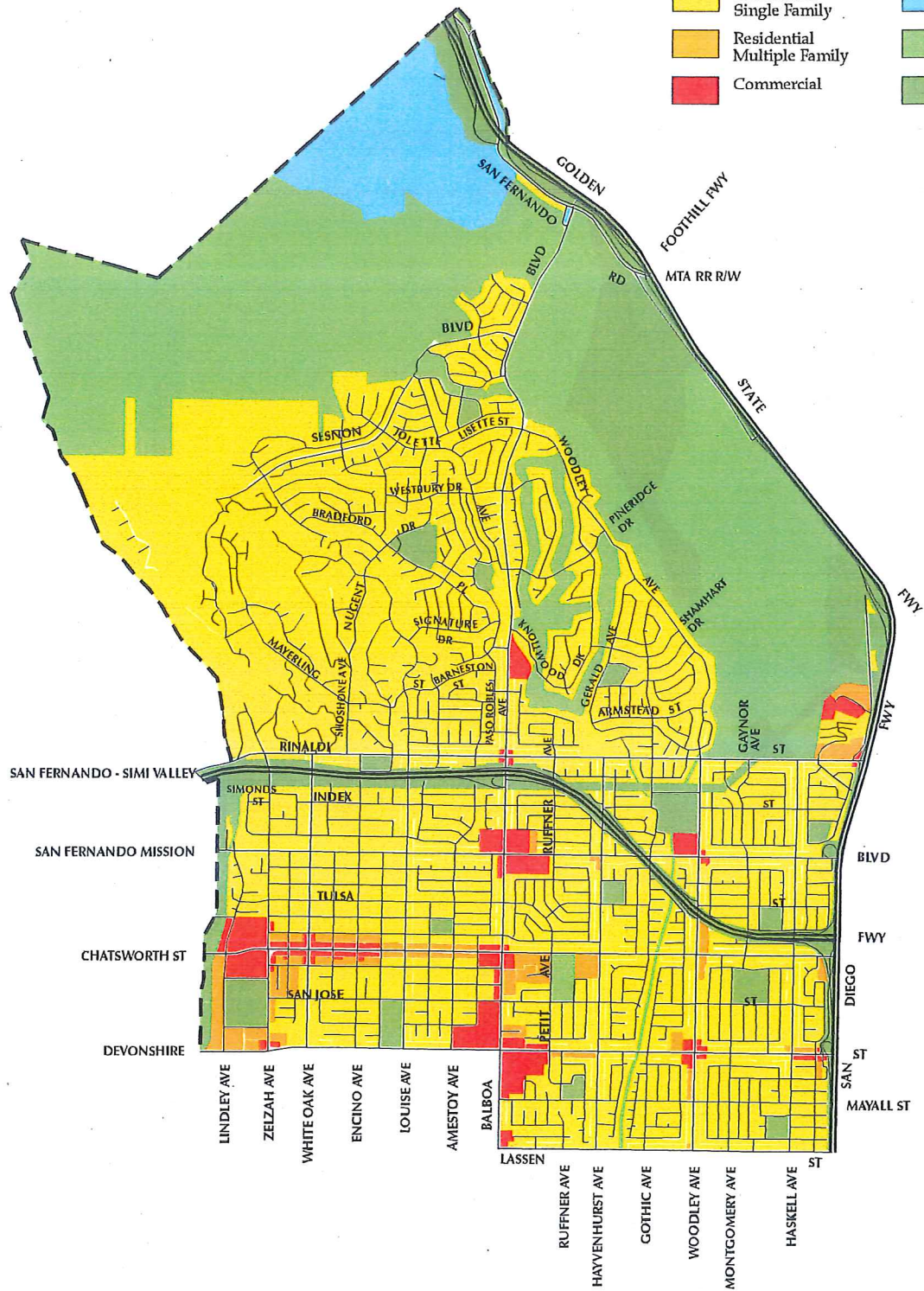

However the draft ordinance was never approved by the City Council.
