- b. The President welcomed everyone.
- c. Roll Call was taken Seven of the eight Board Members were present at the Roll Call: Dave Brown (Secretary), Maggie Elliott (Vice-President), Linda Erdman (Treasurer), Garry Fordyce, Madlena Minasian (President), Kreshell Ramey and Pat Crone. Punam Gohel arrived at 6:22 pm, making all eight current Board members present. The NHWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) normally is seven (see the Bylaws link at www.empowerla.org/nhwnc).

2. <u>Pledge of Allegiance, Voting Eligibility Report, and call for agenda item(s)</u> recusals.

- a. The Pledge of Allegiance was said.
- b. Mr. Brown confirmed that all Board Members' training were compliant and they were eligible to vote. 19 new stakeholders and guests also attended.
- c. There were no Board member recusals regarding any of the agenda items.

2. President's Announcements/Comments:

- a. President spoke about meeting rules, decorum, and time allocations.
- Board vacancies: NHWNC is currently seeking one (1) Residential Board Member, Seat term expiring 2025; one (1) General Board Member, Seat term expiring 2025; one (1) Residential Board Member, Seat term expiring

- 2027; and two (2) General Board Members, Seat terms expiring 2027 and how to apply and the process was stated.
- c. Bylaws change deadline of 4/1/2024.
- d. The LA City Charter 910 monitoring of city services. "Neighborhood Councils shall monitor the delivery of City Services in their respective areas," if anyone is having issues, to let her know.
- e. Greater LA Homeless Count January 23-25, 2024, and a link to register was provided.

LAFD Battalion 10 Firefighters, based in Van Nuys, described coverage area and related the General Safety Mission starting this month, in conjunction with the anniversary of the Northridge Quake. With rain thru this weekend, sandbags are available at all Stations and self-service sand at Fire Station 88, west side of Sepulveda Blvd., south of Oxnard St. There was no indication that LAFD is getting criticism by the City Controller regarding LAFD helicopter use-age compared to LAPD air operations.

Regarding illegal fireworks, the LAFD puts out the resulting fires, but it's up to the City Attorney to provide guidance to the LAPD, which is tasked with enforcement.

Ms. Lorena Espinal, for L.A. City District 12 Councilmember John Lee [818-882-1212; Lorena.Espinal@LACity.org; https://councildistrict12.LACity.gov], Wished everyone a warm New Year and provided information that CD12 has partnered with an organization for an entrepreneur training program that's offered on a continual basis, six weeks per session. Information is about how to start a business and is free of cost to participate. She completed the program and highly recommends it. CD 12 office will be a Homeless Count location for the January 23rd through January 25th Count. CD 12 Joshua Geiger is now in charge of parking enforcement issues. Chronic NHW locations include Haskell between Rayen St. and Parthenia St., as well as the growing encampment at Haskell and Roscoe. The next Conversations with Councils will be on February 5. Questions regarding Motel 6 on Roscoe, west of 405, being converted into a homeless shelter, planning, and land use questions for CD 12 representative Dan Rosales were discussed.

Andres Garcia representing State Senator Caroline Edgewater, Senate District 20, It is based at the Van Nuys district office on Van Nuys Blvd and covers health care and veterans. Described Senate Bills 223 and 457 and co-authored SB 411, the teleconferencing option for Neighborhood Councils. A flaw with the bill was described regarding the vote by an NC to approve using the option. The bill does not detail, and the City Attorney has opined that the vote of 2/3 is of all possible Board seats instead of present and voting members. This is a fatal flaw prohibiting the use of the option by NCs that have vacant seats exceeding the 2/3 Total seat threshold defeats the purpose of the bill for many NCs. There will be an upcoming Town Hall on Friday, January 26th at 6 pm, co-hosted with Assemblywoman Luiz Rivas, the topic being Caltrans, focuses on I-5. A new internship program has started, and applicants Are welcome. Questions were asked about the vacant former Little League location of the VA Plummer property and if any developments are being planned.

President announced that NEA, John Darnell, had emailed her to let her know he was not going to be attending the meeting. .

7. Guest Speakers and Informational Presentations.

8. General Public Comment on Non-Agenda items within the NHWNC jurisdiction Mr. Chris Ahuja, Candidate for Congressional District 32, Primary election date March 5th. Mr. David Levine, former Minutes Writer for the North Hills West Neighborhood Council

thanked the Board for the opportunity to have served and worked with them. He noted the challenges the Board faces while fulfilling its mission to be a liaison between stakeholders and the City.

Mr. Bailey recognized the need to reach out to other Legislators regarding Senate Bill 411

There is work being conducted to resume the annual NC Anniversary Mixer, traditionally on the second Thursday in March, formerly held at CBS Studios Carla's Cafe, which was sold.

Ms. Goldbaum suggested Stakeholders introduce themselves at the start of the meetings.

And expressed concern about the lack of information regarding the proposed adaptive reuse of Motel 6 on Roscoe into a homeless shelter. Particularly with the advent of new construction for a 7-11 on Roscoe in immediate proximity. She questioned if anybody had heard from CD 12 Candidate Serena Oberhiem or a representative.

Ms. Katherine from Chatsworth NC announced a CD 12 Candidates forum tentatively scheduled for February 20th via Zoom, hosted by the Sustainability Alliance for CD 10 and CD 12 Candidates.

Bob Bells reported increasing issues related to smaller prop planes using VNY. He uses Flight Tracker to log the worst offenders and has discovered that most are flight schools. That do repeated touch and goes with abbreviated take-offs/finals that go over his house instead of following the standard flight paths for departures & landings like the jets do. The result is an increased negative impact on the area's quality of life.

Additionally, NHWNC has had a working Adopt-a-Block program in place for almost 20 years, with fluctuating levels of participation as folks move or die, kids leave for college, and new folks move in. Motion by Ms. Minasian, seconded by Ms. Elliott, to request from VCC either the

tools or a refund to the City. Motion passed (7) yes (7-0-0)

17. Discussion and Possible Action: Censure/Grievance #385.

Following the NHWNC Censure of a Board member on October 20, 2022, NHWNC received Grievance #385 logged on 11-17-2022 against the Censure. A NHWNC Voted Response to the Grievance was submitted on April 1, 2023. Following notification of non-receipt, the Response was re-submitted on May 11, 2023. The Grievance database shows a recent Grievance # 421 closed on 01-11-2024. No other NC has an unresolved Grievance pending older than that except NHWNC. Ms. Espinal, CD 12, indicated a Grievance Panel Hearing may be scheduled for February.

NHWNC has consistently expressed concern over non-essential VNY jet charter traffic over the Valley airspace. Areas of NHWNC are subjected to the arrival patterns for air traffic into VNY, including the Valley Charter (Elementary) School, where its teachers, students, and Executive Director are on record expressing concern over the noise and pollution exposure that is impacting student's use of outdoor recess space and during class when lessons are paused due to aircraft noise. In June 2023, UCLA Pediatric Residents and Faculty released a VNY Health Impact Assessment (HIA) that highlights significant harm being done to children under exposure areas and that of our collective region. The HIA also recommends mitigation measures that are echoed in CF 23-1339, including (3): Look at mitigating noise and other impacts from the airport on the surrounding area, including jet blast and sound barrier installations between the airport and adjacent homes and businesses, green space to mitigate climate change and pollution factors on both the east and west side of the property and other opportunities such as tree planting. According to CF 23-1339, the environmental consequences born from the influx of private aircraft over the region have not been studied, nor has the extent of its need or benefit to the City substantiated.

NHWNC joins a number of Valley neighborhood councils that share the concern that the private air traffic over our region is disproportionately impacting the health and quality of life of its dwellers, employees, and our natural spaces. For these reasons and more, the NHWNC wholeheartedly supports CF23-1339 and encourages the City Council to approve and adopt this motion without procrastination or modification. In connection, NHWNC also encourages the City Council to **reject** the Bonseph Helinet LLC proposal that is void of crucial mitigation measures such as appropriate height tree canopy barriers on the perimeter to combat pollution and climate change concerns and power capacity upgrades to significantly reduce toxic ground emissions from the proposed introduction of Jets for Charter to the property that will only exasperate the cumulative crisis the Valley environment is facing. City Council should reject any and all development deals that do not include the above-mentioned mitigation criteria in the original proposal itself, and the City Council should place a moratorium on aviation development permits until CF 23-1339 has been adopted and realized.

MOTION TRADE, TRAVEL AND TOURISM

The Van Nuys Airport (VNY) is one of the busiest general aviation airports in the nation. Despite densely populated residential areas existing prior to VNY's redevelopments over the past twenty years, no mitigation policy measures were created by Los Angeles World Airports (LAWA) to mandate such considerations were implemented.

Over the years, the City has not been provided with a study dictating VNY's general aviation needs, or a study comparing aviation interests with those of community and environmental interests to demonstrate a responsible land use balance for VNY.

The VNY Vision Study was initiated to help inform the Planning Department in their update of the City's Southwest Valley Community Plans: (1) Canoga Park – Winnetka – Woodland Hills – West Hills; (2) Encino – Tarzana; and (3) Reseda – West Van Nuys – Lake Balboa, where the Van Nuys Airport is located, to inform the creation of a Van Nuys Airport Specific Plan to replace the existing Airport Plan and zoning ordinance (Ordinance No. 177327), adopted nearly 18 years ago (CF 05-2286).

Neither the VNY Vision Study or any other planning tool shall replace the need for a new Specific Airport Plan. Community participation and targeted research, study findings and recommendations are essential steps in making any aviation land use decision, including issuing future Request for Proposals (RFPs) related to VNY development. As such, on March 3, 2023 (CF 22-1127), the Council instructed the Planning Department, in consultation with the Los Angeles World Airports, to prepare a Specific Plan for the Van Nuys airport.

I THEREFORE MOVE that the Council instruct the Planning Department, with the assistance of the Los Angeles World Airports, and in consultation with Council District 6 as Committee Chair responsible for the formation and/or operation of the Van Nuys Airport Specific Plan Citizens Advisory Committee, to convene the necessary Citizens Advisory Committee meetings that will serve to provide input during all phases of the development process of the Van Nuys Airport Specific Plan and its relevant studies; and which will include at least one local resident/stakeholder from, but not limited to, Council Districts 2, 3, 4, 5, and 6; and provide an option for Council District office staff participation.

I FURTHER MOVE that the Council instruct the Planning Department, with the assistance of the Los Angeles World Airports, as initially instructed by the Council on March 3, 2023 (CF 22-1127), to prepare a Specific Plan for the Van Nuys Airport (VNY), and thereby replace the Van Nuys Airport Plan and zoning ordinance (CF 05-2286), which was adopted nearly 18 years ago. The Van Nuys Airport Specific Plan should include, but not be limited to, the following:

- 1. Use the results of a forensic audit of VNY per criteria to be set by the Council to better understand the needs for VNY to remain self-sustaining, determine need or independence from future Federal Aviation Administration (FAA) grant use, and for assessment and possible reconsideration of the existing Plan's airport land use map, and in consideration of policy needs.
- 2. Outline criteria for economic studies related to VNY, including cumulative impact on the regional environment and surrounding communities, consideration of percentage of suppliers and workers that are located within Los Angeles County, and defining income designated solely for airport infrastructure versus income benefitting the region directly.
- 3. Look at mitigating noise and other impacts from the airport on the surrounding area including jet blast and sound barrier installations between the airport and adjacent homes and businesses, green space to mitigate climate change and pollution factors on both the east and west side of the property, and other opportunities such as tree planting.

- 4. Define Request for Proposal criteria that contains modernization to meet the City's long term carbon reduction goals, including grey water systems and power capacity upgrades to allow electrified hangars and ramps to reduce emissions from ground operations.
- 5. Establish a community benefit program for the surrounding area.
- 6. Explore how land covered by the Specific Airport Plan can continue to be an economic generator by luring new commercial activity, including possible necessity of filing a formal release with the FAA to change key land use classifications to non-aeronautical where environmental justice and health issues or critical pollution mitigation needs dictate as such.
- 7. Have extensive engagement with airport stakeholders and local residents with defined protocol moving forward.

North Hills West Neighborhood Council (NHWNC), in the southeast quadrant of Council District 12, John Lee, has consistently expressed concern over increasing non-essential VNY jet charter and propeller plane traffic over the Valley airspace. Areas of NHWNC are subjected to the arrival and departure patterns for air traffic into and out of VNY, including the Valley Charter (Elementary) School, where its teachers, students, and Executive Director are on record expressing concern over the noise and pollution exposure that is impacting student's use of outdoor recess space and during class when lessons are paused due to aircraft noise. Similar complaints are increasingly being received from the taxpayer voter residents of the same areas. In June 2023, UCLA Pediatric Residents and Faculty released a VNY Health Impact Assessment (HIA) that highlights significant harm being done to children under exposure areas and that of our collective region. The HIA also recommends mitigation measures that are echoed in CF 23-1339, including (3): Look at mitigating noise and other impacts from the airport on the surrounding area, including jet blast and sound barrier installations between the airport and adjacent homes and businesses, green space to mitigate climate change and pollution factors on both the east and west side of the property and other opportunities such as tree planting. According to CF 23-1339, the environmental consequences born from the influx of private aircraft over the region have not been studied, nor has the extent of its need or benefit to the City substantiated.

North Hills West Neighborhood Council (NHWNC), in the southeast quadrant of Council District 12, John Lee, has consistently expressed concern over increasing non-essential VNY jet charter and propeller plane traffic over the Valley airspace. Areas of NHWNC are subjected to the arrival and departure patterns for air traffic into and out of VNY, including the Valley Charter (Elementary) School, where its teachers, students, and Executive Director are on record expressing concern over the noise and pollution exposure that is impacting student's use of outdoor recess space and during class when lessons are paused due to aircraft noise. Similar complaints are increasingly being received from the taxpayer voter residents of the same areas. In June 2023, UCLA Pediatric Residents and Faculty released a <u>VNY Health Impact Assessment (HIA)</u> that highlights significant harm being done to children under exposure areas and that of our collective region. The HIA also recommends mitigation measures that are echoed in CF 23-1339, including (3): Look at mitigating noise and other impacts from the airport on the surrounding area, including jet blast and sound barrier installations between the airport and adjacent homes and businesses, green space to mitigate climate change and pollution factors on both the east and west side of the property and other opportunities such as tree planting. According to CF 23-1339, the environmental consequences born from the influx of private aircraft over the region have not been studied, nor has the extent of its need or benefit to the City substantiated.

North Hills West Neighborhood Council (NHWNC) joins a number of Valley neighborhood councils that share the concern that the private air traffic over our region is disproportionately impacting the health and quality of life of its dwellers, employees, and our natural spaces. For these reasons and more, the NHWNC wholeheartedly supports CF23-1339 and encourages the City Council to approve and adopt this motion without procrastination or modification. In connection, NHWNC also encourages the City Council to reject the Bonseph Helinet LLC proposal that is void of crucial mitigation measures such as appropriate tree height canopy barriers on the perimeter to combat pollution and climate change concerns and power capacity upgrades to significantly reduce toxic ground emissions from the proposed introduction of Jets for Charter to the property that will only exasperate the cumulative crisis the Valley environment is facing.
