President Madlena Minasian called the Meeting to order at 6:03 p.m.

No Board Member was absent. The NHWNC Board quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is seven (see the Bylaws link at www.empowerla.org/nhwnc), so the Board could take such votes. DISCUSSION: Ms. Ramey was concerned about it. Ms. Minasian noted that "it's a common courtesy." Mr. Fordyce believed it to be "micromanagement."

MAIN MOTION PASSED by a voice vote of the 10 eligible voters present with eight in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart, Hyman and Minasian); two opposed ("No" or "Nay") (Fordyce and Ramey); zero abstained.

MAIN MOTION PASSED by a voice vote of the 10 eligible voters present with eight in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart, Hyman and Minasian); two opposed ("No" or "Nay") (Fordyce and Ramey); zero abstained.

Board Member David Hyman left at this time (7:18), making nine Board Members present (the NHWNC quorum is seven). The next Item addressed was Item #11.

10. Guest Speakers and Informational Presentations.

A. Presentation from SoCal SFV Community Group Consultant Timi Romolini regarding Van Nuys Airport Expansion.

Ms. Romolini showed slides and presented. She described Airport operations and expansion plans, and health concerns from increased air traffic. She said that all Neighborhood Councils oppose this because of 1) an unauthorized increase in air traffic; and 2) a lack of physical connections for planes to use clean energy services. She noted that there was no competitive Request for Proposal, and other project concerns. She believed that the project report omits critical information, and that the City Council could but isn't taking control of the process. Mr. Fordyce thought that Ms. Romolini, as a consultant, was a paid lobbyist, and he claimed that she is; she confirmed and explained that she was not a paid lobbyist. She explained many airport and aviation concepts and procedures.

MOTION (by Ms. Minasian, seconded by Ms. Erdman): The North Hills West Neighborhood Council will submit an amendment to Community Impact Statement (CIS) supporting Council File CF 22-1489 Van Nuys Airport (VNY) / Development Projects / Community Impact / VNY Citizens Advisory Council.

MOTION PASSED unanimously by a voice vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Minasian and Ramey); zero opposed); zero abstained.

Discussion and possible action to approve emailing the linked letter regarding systemic issues at LAWA, a Rejection of the Bonseph Helinet Lease proposal, and support for a Moratorium on aviation development/redevelopment at VNY airport.

Ms. Minasian noted that a draft letter was on the NHWNC website.

MOTION to CALL FOR THE QUESTION (by Ms. Minasian): **PASSED**; zero opposed; zero abstained.

MOTION (by Ms. Minasian, seconded by Ms. Erdman): The North Hills West Neighborhood Council approves emailing the linked letter regarding systemic issues at LAWA, a Rejection of the Bonseph Helinet Lease proposal, and support for a Moratorium on aviation development/redevelopment at VNY airport.

MOTION PASSED unanimously by a voice vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Minasian and Ramey); zero opposed); zero abstained.

11. <u>Discussion and possible action</u> to approve the 2023-2024 Fiscal Year Administrative Packet, including the Budget.

FUNDING MOTION (by Ms. Minasian, seconded by Ms. Crone): The North Hills West Neighborhood Council approves the 2023-2024 Fiscal Year Administrative Packet, including the Budget.

DISCUSSION: Mr. Fordyce asked what the Minutes Writer does and claimed that the NHWNC has never had an Administrative Assistant.

FUNDING MOTION PASSED by a voice vote of the nine eligible voters present with seven in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart and Minasian); one opposed ("No" or "Nay") (Fordyce); one abstained (the NHWNC does not count abstentions as votes) (Ramey).

The next Agenda Item addressed was Item #10.

12. <u>Discussion and possible action</u> to purchase Neighborhood Watch signs, NTE \$1,000.

FUNDING MOTION (by Ms. Minasian, seconded by Mr. Gohel): The North Hills West Neighborhood Council will purchase Neighborhood Watch signs, NTE \$1,000.

DISCUSSION: Mr. Brown explained that the signs "would replace" old faded signs. The cost includes installation.

FUNDING MOTION PASSED by a voice vote of the nine eligible voters present with seven in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart and Minasian); one opposed ("No" or "Nay") (Fordyce); one abstained (the NHWNC does not count abstentions as votes) (Ramey).

13. <u>Discussion and possible action</u> to purchase a three-year AppleCare warranty for a MacBook Air laptop, NTE \$200.

14. <u>Discussion and possible action</u> to purchase NHWNC stickers, NTE \$450.

FUNDING MOTION (by Ms. Minasian, seconded by Ms. Ramey): The North Hills West Neighborhood Council will purchase NHWNC stickers, NTE \$450.

DISCUSSION: Ms. Minasian explained the need.

MOTION PASSED unanimously by a voice vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Minasian and Ramey); zero opposed); zero abstained.

15. <u>Discussion and possible action</u> to purchase microphones and additional equipment for the Board meet-ing sound system, NTE \$5,000.

FUNDING MOTION (by Ms. Minasian, seconded by Ms. Hart): The North Hills West Neighborhood Council purchase microphones and additional equipment for the Board meeting sound system, NTE \$5,000.

DISCUSSION: Ms. Minasian explained that the equipment would be owned by the NHWNC. Equipment used at this time belonged to New Horizons. Mr. Fordyce claimed that "we have no documentation." The process was explained to him.

Board Member Kreshell Ramey stepped out of the meeting at this time, making eight Board Members present online (the NHWNC quorum is seven).

MOTION PASSED by a voice vote of the eight eligible voters present with seven in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Gohel, Hart and Minasian); one opposed ("No" or "Nay") (Fordyce); zero abstained.

MOTION (by Ms. Minasian, seconded by Ms. Crone): The North Hills West Neighborhood Council appoints Maggie Elliott and Dave Brown to be the liaisons to Volunteers Cleaning Communities (VCC).

DISCUSSION: Mr. Bailey reported that "several Neighborhood Councils" have the issue of not knowing what VCC did with their supplies. Ms. Minasian reported that VCC Founder Jill Mather [JillMather@earthlink.net] hasn't responded to several attempts to contact her.

MOTION to CALL FOR THE QUESTION (by Ms. Minasian): **PASSED**; zero opposed; zero abstained.

MOTION PASSED unanimously by a voice vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Brown, Crone, Elliott, Erdman, Fordyce, Gohel, Hart, Minasian and Ramey); zero opposed); zero abstained.

Board Member Pat Crone left at this time (8:25), making eight Board Members present (the NHWNC quorum is seven).
