Minutes of the NHWNC Planning/Land Use Committee Meeting Held on Thursday, October 4, 2012

1. CALL TO ORDER

The meeting was called to order by Committee Co-Chair Robin Tyler at 6:31 p.m.

There were no speakers who came forward for public comment. Robin Tyler took this opportunity to thank Debra Francisco for bringing cookies to the meeting.

4. PRESENTATIONS

There were no presentations.

5. OLD BUSINESS

a. Motion to rescind August 30, 2012 action to join Home For Good Action Plan making the commitment to partner with OTHER LEADERS to end chronic and Veteran homelessness by 2016

A motion was made by Robin Tyler to rescind the August 30, 2012 action to join Home For Good Action Plan making the commitment to partner with OTHER LEADERS to end chronic and Veteran homelessness by 2016. This was seconded by Peggy Burgess.

Peggy Burgess stated that it is necessary to take action on this matter since the organization is not what it says it is.

ACTION: The motion passed 2-0 with no opposes and abstentions.



6. NEW BUSINESS

 Motion to rescind all former actions that oppose the regulation of Community Care Facilities (CCFO) and issue confirming Community Impact Statement (CIS) to City Clerk

Peggy Burgess informed the committee that she has been working on this issue since 2005. She said that there is a need to stop illegal group homes from operating, hence the need to rescind the action. (Committee Chair John McGovern arrived.)

Peggy Burgess requested that the motion be amended to include, but not be limited to, the actions of July 19, 2012.

The motion, as amended, to rescind all former actions that oppose the regulation of Community Care Facilities (CCFO) including, but not limited to, the actions of July 19, 2012 and issue confirming Community Impact Statement (CIS) to City Clerk, was made by Robin Tyler and seconded by Peggy Burgess.

The motion, as amended, unanimously passed by general consent (3-0).

c. Motion to oppose requested zone change by Restaurant Depot from RA-1 residential to commercial

Robin Tyler made a motion to oppose the requested zone change by Restaurant Depot from RA-1 residential to commercial. This was seconded by John McGovern.

Lauretta Masters publicly commented that this was her third time to attend a meeting on this matter. She said that, as a resident of Chase Street, she opposes the proposed zone change due to the negative impact that the development will have on her street.

A member of the audience (no speaker card) stated his approval of the Restaurant Depot development.

The motion unanimously passed (3-0) with no opposes or abstentions.



d. Motion to oppose the proposed Jetro Cash & Carry/Restaurant Depot Case No. CPC-2012-2014-GPA-ZC-SPR project at 16062 Chase St. and attendant Environmental Report including DOT Traffic Assessment ENV-2012-1215-EAF

The Committee voted unanimously to

- (a) Oppose the proposed Jetro Cash & Carry/Restaurant Depot Case No. CPC-2012-2014-GPA-CZ-SPR project at 16062 Chase St. and attendant Environmental Report including DOT Traffic Assessment ENV-2012-1215-EAF; and
- (b) Request the NHWNC Board to approve at its next General Meeting, to be held on October 18, 2012, the draft letter of opposition for submission to the City Planning Commission.

There were no opposes or abstentions.
