Council File 23-1134, Economic Roundtable / Economic Study / Annual Rent Increase / Rent Stabilization Ordinance (RSO) / Sole-Source Contract (Blumenfield – Soto-Martinez – Yaroslavsky): Introduced October 13, 2023 and referred to Homelessness Committee. Motion is authorizing the Los Angeles Housing Department (LAHD) to negotiate and execute a sole-source contract, subject to eh approval as to form by the City Attorney, with Economic Roundtable, for an amount not to exceed \$180,000 from the Rent Stabilization Trust Fund 43/440, the term of the agreement shall be from date of execution to 12 months to conduct an economic study

of the formula for setting the RSO annual allowable rent increase, with the understanding the study should conclude within 3 months.
